4. SPSA:	School Wide Plan Presentation by Fred Hilgers	Olivero began the meeting explaining the SPSA training attended by himself and Hall. Sometime before October 5 th , SSC will need to work on this lengthy, 8 tab, document for the 2020-2021 school year. We will need to look at data and decide if the funds were utilized to positively affect student achievement. Fred Hilgers, district Resource Teacher from Financial Planning, Monitoring and Accountability department, presented a Power Point Presentation; School Wide Programs (SWP). Hilgers explains after the presentation that the purpose of today's meeting is to decide if

		<p>University City HS will be a Schoolwide Program (SWP) school or a Targeted Assistance (TA) School. This decision is linked to the Title I funding. Olivero stated that there was a time when only Title I identified students would receive supports as opposed to a system where all students who need help, can have access to the supports. SWP is an "all in this together" culture where a TA school could lead to a culture of "why do those students only get support". Smaller schools and private schools could benefit from the TA model where a larger gap between students' income levels exists. Olivero gave the following example to clarify. UC has used some of the Title I funds to provide ELD support classes for students needing extra English support. This is supplementary support in addition to their English course. Some of the students in the class may or may not be Title I identified but all students in the class can benefit from the ELD support. This is the SWP model. Hilgers continues by explaining that the rest of the Power Point our SSC was trained earlier this year. He added that the SWP model wraps directly into the SPSA. Hall made a motion that UCHS adopts the SchoolWide Program school model for the 2020-2021 school year. Second by Boerner. No discussion or questions. All approve 8-0-0.
